The submission of articles for the scientific journal «Scientific Bulletin of V.O.Sukhomlynskyi Mykolaiv National University. Psychological Sciences» Vol. 1(20) is announced Submission is open until October 25<sup>th</sup> 2020

*«Scientific Bulletin of V.O.Sukhomlynskyi Mykolaiv National University. Psychological Sciences»* is a scientific periodical founded by V.O.Sukhomlynskyi Mykolaiv National University <u>http://mdu.edu.ua/</u> for publication of results of theoretical and empirical researches in the field of psychology.

The articles consider the problems of psychological theory, empirical research, history of psychology, general psychology, pedagogical psychology, age psychology, differential psychology, personality psychology, labor psychology, social and organizational psychology, legal psychology, clinical and medical psychology. Current trends and prospects for the development of psychology in Ukraine and abroad are discussed.

The aim of the Journal is to promote a deeper understanding of psychological phenomena, their determination, features, and patterns.

The Journal cooperates with the higher educational institutions of Ukraine and other countries, national and regional government authorities. Such cooperation includes the placement of information materials, publication of scientific articles, conducting public discussions, scientific seminars, symposia, conferences.

The priorities of the Journal are supporting of young scientists, investigation of the problems of modern society, personal problems, informing the scientific community about modern psychological researches and the problems of psychological education.

The articles published in the Journal are assigned a *Digital* Object Identifier (DOI).

The Editorial Board of the Bulletin recommends the authors read the "Instructions for Authors" before submitting articles for consideration.

The submission of the article for consideration is recognized by the editorial board as an acknowledgment that the author or authors are aware of the following requirements and agree with them.

#### **Guidelines for Authors**

a) The Bulletin accepts publications containing 0.5 to 1.5 author's sheets (1 author's sheet = 40.000 characters including spaces), which have not been previously published.

b) Publication language: Ukrainian, English.

# c) The article should be clearly structured and contain the following mandatory elements:

• Introduction – hypothesis, aim, objectives, analytical review of the problem;

• Materials (sampling, tools) and methods;

- **Results** presentation and justification of the received scientific results;
- Discussion comparison of the received results with other researches in the field
- Conclusions from this study and prospects for further investigations in the field
- Literature

d) The article should be supplied with annotations and keywords in Ukrainian and English. For articles in Ukrainian, an English language annotation should consist of at least 1800 characters (spaces included). For articles in English, an annotation in Ukrainian should respond to the requirement above (Порядок формування переліку наукових фахових видань України, 2018). Annotations should reflect the course of the research and the conclusions drawn.

# 2. The structure of the article

- UDC index of the Universal Decimal Classification, the numerical expression of the article content <u>https://teacode.com/online/udc/</u>.
- Name and surname of the author in the Nominative case
- Academic degree, academic title, position in the Nominative case (e.g. Doctor of Psychological Sciences, Professor)
- email
- Researcher ID (ORCID ID, Researcher ID, Scopus ID if available).
- Institution the author represents, city, country in the Nominative Case (e.g.: Taras Shevchenko National University of Kyiv, Kyiv, Ukraine; Vasyl Stefanyk Precarpathian National University, Ivano-Frankivsk, Ukraine).
- **Title of the article** (in Ukrainian) the title should be short and reflect the content of the article.
- Abstract (in Ukrainian) should be substantive, not descriptive; at least 1800 characters for an article in English.
- **Keywords** (in Ukrainian) 5-8 keywords.
- The main text of the article should contain the mandatory elements listed in paragraph 1c of these requirements. The text should be properly proofread, it should not contain any spelling and punctuation errors. The editors reserve the right to shorten or edit the texts submitted for publication.
- Literature bibliographic list (a reference list is mandatory element, it should be compiled in accordance with the standards of bibliographic description (see: standard DSTU 8302: 2015 "Information and documentation. Bibliographic reference. General provisions and rules of compilation") in alphabetical order. For the correct design of bibliographies, the Editorial Board recommends authors to use the following online resources: <a href="http://lib.znau.edu.ua/jirbis2/images/phocagallery/2017/Pryklady\_DSTU\_8302\_20\_15.pdf">http://lib.znau.edu.ua/jirbis2/images/phocagallery/2017/Pryklady\_DSTU\_8302\_20\_15.pdf</a>.
- References a list of references translated into English. The order of the sources in the References must fully correspond to the List of References. The bibliographic list should be formed according to the APA style(<u>APA Style</u>, American Psychological Association). It is recommended to use the following online resource

for the correct transliteration of Ukrainian authors' surnames: <u>https://pasport.org.ua/vazhlivo/transliteratsiya</u>.

- Author's full name transliterated in Latin alphabet.
- Institution the author represents, city, country correct English language title (e.g.: *Taras Shevchenko National University of Kyiv, Kyiv, Ukraine; Vasyl Stefanyk Precarpathian National University, Ivano-Frankivsk, Ukraine*).
- Article title (in English)
- Abstract (in English) should be contain at least 1800 characters for an article in Ukrainian.
- Keywords (in English).

# **3.** Requirements for References

- References to quoted sources are given in the text in square brackets after the quote. The first digit is the number of the source in the reference list, the second is the page number, for example: [3, p. 15] or [2, p. 35-45].
- The text of the article is submitted to the Editorial Board of the Bulletin in doc. aбo docx. electronic formats.
- Print: Times New Roman, size 14, interval: 1.5.
- Paragraph indention: 1.25.
- Page margin: left -20 mm, right -20 mm, top -20 mm, bottom -20 mm.
- Illustrations should be sent as separate files in .jpg, jpeg, png formats.
- If the article contains tables, formulas and (or) illustrations, they should be compact, entitled, font Times New Roman, size 12. Tables and figures should not be larger than the width of the page.

# 5. Possible reasons for rejection

The manuscript can be rejected for the following reasons:

- Partial or complete disregard by an author of the above requirements.
- The text of the article is poorly proofread, contains a significant number of spelling and punctuation errors.
- There is no extended English annotation or it is translated by machine translation.
- The article is not structured, there is no logic in presentation of the content.
- Non-compliance with the principles of academic integrity (the article contains plagiarism, self-plagiarism, falsified data, etc.).
- The article does not contain scientific novelty, has no practical or theoretical value.

To submit an article in the scientific journal **Issue 1 (20), 2020**, it is necessary to send an article prepared in accordance with these requirements to the Editorial Board e-mail box <u>visnyk.editor@mdu.edu.ua</u> no later than **October 25, 2020**.

After receiving confirmation from the Editorial Board that the article has been accepted for publication, the publication fee payment details are provided.

The author must send back a scanned receipt of the publication fee payment.

The publication fee covers the costs for editing articles, layout and printing of the journal, as well as mailing the journal to the authors.

The files should be named as in the examples: Kravchuk\_article, Kravchuk\_receipt.
